

Qualifying recognised overseas pension schemes -Member information for the overseas scheme manager

About this form

Use this form to give your scheme manager the information they need to transfer sums or assets held within a qualifying recognised overseas pension scheme to another qualifying recognised overseas pension scheme (QROPS). You must provide this information to your overseas scheme manager within 60 days of your transfer request. The scheme manager will need this information before proceeding with your transfer request and HM Revenue and Customs (HMRC) may ask to see this.

Tax charges

There are circumstances in which you may have to pay UK tax on this transfer or later payment out of the overseas scheme even if you're not resident in the UK. Please note if you do not provide this information to your overseas scheme manager within 60 days of your transfer request, your transfer will be subject to the overseas transfer charge.
